Cllr Grover:

- Collaboration with ELDC/Boston has been a success over the past 7 years; £47m saved with £277m of external funding provided.
- The £800 bid submitted by the Parish Council has been approved and due to be released shortly.

Cllr Roberts:

- Bus Stop concerns raised will now go to committee who will meet later in the year.
- Council tax rise to be announced shortly and is expected to be well received by residents
- Request made to inspect the pooling of water by the corner house at the junction of Raithby road as a hazard with flooding/icy when frosty. Cllr Roberts will investigate it and report back to council. He also advised that logging a job via Fix My Street may escalate the issue and will trigger further action by the local council. He said that he will look for it being reported.
- Footpath No366 cessation has now been approved.
